**Invitation to Bid No. 11-11-36**  
**Construction of Supply Office Warehouse**

1. The West Visayas State University, through **Fund 164** intends to apply the sum of **ONE MILLION SIX HUNDRED SEVENTY TWO THOUSAND PESOS ONLY (PhP 1,672,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Construction of Supply Office Warehouse**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The West Visayas State University now invites bids for **Construction of Supply Office Warehouse**. Delivery of the Goods is required for **ninety (90) calendar days**. Bidders should have completed, within two (2) years from the date of submission and receipts of bids, a contract similar to project. The description of an eligible bidder is contained in the bidding documents, particularly, in Section II. Instructions to bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".  
Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and which similar to Commonwealth Act 138.
4. Interested bidders may obtain further information from the office of the **BAC Secretariat** and inspect the Bidding Documents at the address given below during **8:00 A.M. to 5:00 P.M.**  
A complete set of Bidding Documents may be purchased by interested Bidders on **November 24 - December 9, 2011** from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **THREE THOUSAND PESOS ONLY (PhP 3,000.00)**.  
It may also be downloaded free of charge from the website of the Procuring Entity, provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.
5. The West Visayas State University will hold a Pre-Bid Conference on **November 29, 2011, 9:30 A.M. at BAC Secretariat Office, 2<sup>nd</sup> Floor Administration Building, WVSU Main Campus, La Paz, Iloilo City** which shall be open to all interested parties.
6. Bids must be delivered to the address below on or before **9:30 A.M. on December 12, 2011**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.  
Bid opening shall be on **December 12, 2011, 9:30 A.M. at BAC Secretariat Office, 2F Administration Building, WVSU Main Campus, Luna Street, La Paz, Iloilo City**. Bids will be opened in the presence of the bidders representatives who choose to attend at the address below. Late bids shall not be accepted.
7. The West Visayas State University reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
